

Competition Terms and Conditions

5. The competition commences on 19 March 2018 at 9:00 and closes on 1 April 2018 at midnight. No entries received after 1 April 2018 at midnight will be allowed.

In order to participate, participants must post a picture of themselves, their family or friends, posing with the Beacon bunny, which photo must be posted on the N1 City Mall's Facebook fan page (<https://www.facebook.com/N1-City-Mall-Cape-Town-South-Africa-189596779060>). The post must also include the #N1EasterRewards. The Beacon bunny will be located in the Truworths Court for the duration of the competition.
7. Each participant is allowed multiple entries.
